Refunds

BITCHES IN SEASON ARE NOT ALLOWED ON THE TEST GROUNDS.

Prior to closing, all scratches and refunds will be handled by Entry Express. After closing on September 29, 2021 scratches are handled by the Field Trial Secretary.

Bitches in season, dogs who are ill or injured or who have died may receive a refund of their entry fee. A veterinarian's certificate or confirmation of an injury on site by the Test Committee is required. Requests for refunds must be in writing and provide a payee and address for the refund. The request must be received by the Test Secretary (electronically to gooddogranch@bellsouth.net is highly recommended) within 5 days of the conclusion of the event. Refunds for hardship or extenuating circumstances are at the sole discretion of the Test Committee. A \$25 processing fee will be retained for all refunds to cover AKC charges and administration.

Handlers are strongly encouraged, as a courtesy to other handlers, to contact the Trial Secretary IN ADVANCE of the event if they are a scratch.

Running Order

The closing of the Dow Jones Industrial Average (DJIA) on Tuesday, October 19 will determine the starting dog in all stakes. The starting dog will be published on Entry Express on Wednesday prior to the event start. You MUST check Entry Express to determine when you will run. It is not generally based on your running order number. The first 10 dogs in the Open and Amateur will run in order. The decision on departures from the running order in one stake which may adversely impact another stake shall be made by the Field Trial Marshals. Judges will be requested to impose a system of rotation in all stakes. Systems of rotation will be announced prior to the start of each stake. The Open All-Age Stake will be considered of primary importance and the Amateur All-Age Stake will merit next consideration.

Directions

From the North. Take I-75 So. to exit 382. Exit right on to Williston Rd & Rt 121S. Follow HWY 121 to Cty Rt 335, turn right, cross railroad tracks and turn right at next intersection, 87th Ln. Follow 87th Ln and turn right into Lazy J Ranch. Please obey speed limit signs on Rt 335 through the area of Whitehurst farm and business. Signs will be posted.

From the South. Take I-75 No. to exit 354 in Ocala. Turn left on to US 27 North, follow US 27 into Williston and turn right at traffic light on to No. Main St. (Hwy 27 & US 41). Follow Hwy 27 approx 5 miles. Turn right at flashing light in Raleigh on to Hwy 335, turn left on 87th lane and follow around to Lazy J Ranch on right. Signs will be posted.
